Beer drinkers may have to be tea totalers for awhile

May 3 (UPI) — Officials warned of traffic delays on a Wisconsin highway when an overturned truck spilled beer into the roadway.

Menomonee Falls police shared photos on social media showing the semi truck on its side in the northbound lanes of Interstate 41 on Thursday with cases of Miller High Life beer spilling out from its rear.

Two lanes of traffic were closed for the cleanup operation and police warned drivers to seek alternate routes or expect delays.

Adding to the slander was the fact the newspaper did not contact Garcia for her side of story, rather publishing a one-sided press release Delta issued, which unfortunately is the typi-



<u>Jose Hernandez ...</u> Astronaut makes appearance


NASA astronaut Jose Hernandez made a visit to the Cinco de Mayo celebration in Stockton.

Hernández was born in French Camp but calls Stockton, his hometown. His family is originally from La Piedad, Michoacán, Mexico.In an August 25, 2009, conversation with President Felipe Calderón of Mexico, Hernández stated that as a child, he lived half the year in La Piedad and half in the United States.

As a child, Hernández worked alongside his family and other farmworkers throughout the fields of California, harvesting crops and moving from one town to another. He attended many schools and didn't learn to speak English until he was 12. His first memory of space is about adjusting the television in order to watch the Apollo 17 mission in 1972.

Hernández participated in Upward Bound during high school, a Federal TRIO program that prepares students for college. He graduated from Franklin High School in Stockton. José Hernández was a generation one college student to graduate with a bachelors and masters degree.

He earned a B.S. in electrical engineering from the University of the Pacific in 1984. In 1986, Hernández earned an M.S. in electrical and computer engineering from the University of California, Santa Barbara. While in college, he was involved in the Mathematics, Engineering, Science Achievement (MESA) program, an academic preparation program that provides support to students from educationally disadvantaged backgrounds so they can attain four-year degrees in science, technology, engineering or math (STEM) fields. Hernández worked from 1990 to 2001 at Lawrence Livermore National Laboratory in Livermore. While there, Hernández, along with a commercial colleague, developed the first full-field digital mammography imaging system. This invention aids in the early detection of breast cancer.

NASA, Hernández was selected in May 2004. In February 2006 he completed Astronaut Candidate Training that included scientific and technical briefings, intensive instruction in Shuttle and International Space Station systems, physiological training, T-38 flight training, and water and wilderness survival training. On completing this initial training, Hernández was assigned to the Shuttle Branch to support Kennedy Space Center Operations in support of shuttle launch and landing preparations.

In May 2007, Hernández served as an aquanaut during the NEEMO 12 mission aboard the Aquarius underwater laboratory, living and working underwater for eleven days. Hernández worked various technical assignments until his selection on July 15, 2008, as a mission specialist on the STS-128 mission, which launched on August 28, 2009.

The STS-128 mission ended its 13-day journey on September 11, 2009, at Edwards Air Force Base, California. In 2023, a film entitled A Million Miles Away, starring Michael Peña was released and was about Hernández's NASA career.[24] The film was based on Hernández's 2012 autobiography, "Reaching for the Stars: The Inspiring Story of a Migrant Farmworker Turned Astronaut.

In 2001, Hernández joined the Johnson Space Center, in Houston, Texas. After three years and being turned down eleven times for astronaut training by

Previously, the organization was accredited through the Council on Accreditation (COA) since 2016.


This accreditation decision represents the highest level of accreditation that can be given to an organization and shows CHS' substantial conformance to the CARF standards. An organization receiving a Three-Year Accreditation has gone through a rigorous peer-review process. It has demonstrated to a team of surveyors during an on-site visit its commitment to offering programs and services that are measurable, accountable, and of the highest quality.

"This achievement is an indication of Children's Home of Stockton's dedication and commitment to improving the quality of the lives of the persons served," as highlighted in the accreditation report. "The entire organization diligently works to provide youth opportunities to better themselves and find hope for a healthy future."

Children's Home of Stockton is a nonprofit organization operating a 16-bed Short-Term Residential Therapeutic Program (STRTP) for foster youth ages 12-18, now accredited through CARF International, as well as an 18-bed housing and homeless prevention program for Transition Age Youth (TAY) ages 18-24 in San Joaquin County. The agency is Medi-Cal certified as a Specialty Mental Health Provider and offers Transition Aftercare services to provide ongoing support. CHS was established in 1882 and has more than 140 years of serving vulnerable youth in the community.

The last hole is the hole I wanted to start at but a survey crew was working there so I didn't stop.

They were still there when I came back through but I stopped anyway and pulled 2 more fish out of that hole. One was just a decent keeper but the other one was bout 17+ inches and bout 2 pounds.

I had to pull them up through a whitewater to get them to me and I really didn't think the big one was going to stay on but it did.

I decided to call it a day after that. I didn't need to try for a 5th one. Those 4 were plenty.

I tried to fillet the big 25 incher and it was nearly a total disaster.

Was nothing like the Stripers I fillet all the time. I decided that I wouldn't do that again.

"The dog is clearly remorseful but the deer was muttering something about breaking free and doing it all again tomorrow," police wrote.



Wayward zebra returns from freedom run

May 6 (UPI) — The zebra who spent several days on the loose in western Washington was successfully recaptured and returned to her owner.

The zebra, named Shug, was one of four to escape a trailer on Interstate 90 on April 28, and was the only one to remain on the loose after a few hours of rescue efforts.

North Bend Mayor Mary Miller said Shug was finally cornered Friday in a wooded area in the Riverbend neighborhood.

Miller was on scene for part of the rescue operation.

"I helped where I could," she told KCPQ-TV. "We used fences and made the enclosure smaller and smaller. It was all very gentle and very relaxed. We weren't dragging fencing. We weren't making noise. We were heavy lifting and moving things around and she eventually just walked into the trailer."

She said the zebra's captors included a large group of animal control officers and volunteer wranglers.

"It really was a community effort," Miller said. "The group of wranglers weren't from the community, but they just jumped in. They were professionals and they knew what to do and they worked as a team."

David Danton, a former bullfighter and professional wrangler, was among the team who helped capture Shug. He previously assisted with the capture of one of the other escaped zebras.

"It's not every day you catch a zebra," Danton said. "We just are doing what neighbors do." Shug will be reunited with her three cohorts, officials said.

"The zebra will be transported to Montana, which is where the dazzle of four zebras was headed before they escaped," Regional Animal Services of King County said in a statement.

Ashley Class said she and her husband initially thought their daughter was merely imagining the presence of a monster in the closet of her farmhouse bedroom.

"She was saying she heard monsters in her bedroom wall, but we'd been watching Monster's Inc.," Class told People.com. "She was a little speech delayed, so when she tried explaining it, we thought she meant there were monsters in her closet."

Class said it wasn't until after numerous incidents where her daughter heard the supposed specter that she and her husband started spotting bees in the attic.

Beekeeper Curtis Collins was called to the home and gave Class a scare when he used a thermal imaging camera on the wall of her daughter's room.

"I kid you not, it lit up like Christmas in the wall right next to my daughter's closet," Class told NBC News. "When I first thought it was like, a man in the wall, I was really startled."

Collins ended up removing more than 50,000 bees from inside the walls of the home. He said the hive was twice the size of any other hive he has ever found hiding inside a house.

"It was like an apocalypse, is all I can think about," Class said. "It's just all these bees started flying out."

She said the bees are leaving her with a \$20,000 home repair bill that her insurance has refused to cover. Beach-goers in Galveston and Freeport recently reported coming across the unusual objects — small rectangular blocks attached to larger rectangular blocks — in the sand along the shoreline.



The objects had waterlogged notes attached asking the finders to call a phone number.

The Gulf Center for Sea Turtle Research revealed on social media that the blocks are "wooden effigies" meant to emulate sea turtles "in an effort to understand how weather patterns and ocean currents influence annual sea turtle strandings."

"A total of 80 effigy drifters were released off Chandeleur Island, La., and over half are headed towards the Texas coast. Four have already been found this week in our area," the center said.

The post asked anyone who finds an orange-painted block to contact the Gulf Center so research data can be collected.
