Baby seal takes a crawl through the highways of San Francisco

Feb. 18 (UPI) — The California Highway Patrol came to the rescue of a



juvenile sea lion that wandered onto a busy highway in the San Francisco Area.

CHP San Francisco said on social media that officers responded to U.S. Highway 101 after a sea lion — initially misidentified as a seal was seen in the northbound lanes, near the Candlestick Park offramp.

"The reporting party was able to avoid a collision with the seal pup, but was concerned that another vehicle may strike and hurt it," the post said.

The driver assisted officers with guiding the sea lion to the right shoulder, through an opening in the retaining wall and back into the San Francisco Bay.

The CHP, mistaking the animal's species, dubbed the animal "Lou Seal."

"We never know what to expect on any given day," the post said. "CHP officers are always ready and willing to ensure safety, service, and security to all, including those with flippers and even lost members of Lou Seal's family."

The induction ceremony will take place at the adjoining Linden Performing Arts Center immediately following dinner.







A group of visitors once asked an 82year-old his age.

California water system

California's economy and culture have always been shaped by the abundance or scarcity of water.

The Golden State's economy, agricultural production, and population have grown to number one in the nation, largely in pace with the development of its water resources.

California receives 75 percent of its rain and snow in the watersheds north of Sacramento. However, 80 percent of California's water demand comes from the southern 2/3 of the state.

As people flocked to the mild climate and agricultural richness of southern California in the late 1800s and early 1900s, it was quickly apparent that the region's water supply wouldn't support the swelling population. Several water projects were built to import the precious resource to Southern California and the Central Valley.

Central Valley Project

In the 1930s, the federal government got involved, building the Central Valley Project (CVP) to support the arid but fertile Central Valley and its agricultural economy. Built by the U.S. Bureau of Reclamation, the CVP transports water from Lake Shasta in the north to Bakersfield in the southern San Joaquin Valley.

State Water Project

California's State Water Project (SWP) was constructed in the 1960s and 1970s to supply water to more than 27 million people and 750,000 acres of farmland. Planned, constructed, and operated by DWR, it is one of the world's most extensive systems of dams, reservoirs, power plants, pumping plants and aqueducts and remains key to California's economy. The Edmonston Pumping Plant, south of the Tehachapi Mountains, pumps water 1,926 feet up and over the ridge into Southern California, making it the world's tallest water lift.

Colorado River

The Colorado Aqueduct, built in the 1930s, transports water from the Colorado River to Southern California. It's operated by the Metropolitan Water District of Southern California (MWD) and is the region's primary source of drinking water. Features & Considerations

The Delta

At the heart of California's water system is the Sacramento-San Joaquin Delta. It's a natural feature of California's hydrology, where the state's two mighty rivers join and find their way to sea. It is also the export pool of the SWP, pumping water to millions of people in the San Francisco Bay Area, San Joaquin Valley, Central Coast, and Southern California. Benefits

In addition to supplying water to farms, cities, and industry, the SWP provides flood control, recreational opportunities, and water for fish and wildlife. The SWP's water storage facilities provide year-round recreation opportunities for communities and tourists. Lake Oroville, the SWP's largest reservoir, was originally built in response to the Yuba City flood of 1955. It serves a critical function to prevent catastrophic flood damage in exceptionally rainy years. Environment

California's heavily engineered water system is blamed by many for declining fish populations, yet simultaneously praised by others for timely releases of cool water to sustain salmon, steelhead and other species. CVP and SWP pumps in the Delta operate under State and federal guidelines to reduce their effects on sensitive fish species. California continues to modernize its water system to increase water supply reliability while reducing impacts to wildlife and the state's



Re-living the Old West

Cowboy mounted shooting (also called western mounted shooting and mounted shooting) is a competitive equestrian sport involving the riding of a horse to negotiate a shooting pattern. Depending on sponsoring organizations, it can be based on the historical reenactment of historic shooting events held at Wild West shows in the late 19th century. Modern events use blank

ammunitioninstead of live rounds, certified to break a target balloon within twenty feet.

In the spirit of the soldier and cowboy, one organization, the Cowboy Mounted Shooting Association (CMSA) was created in the mid-1990s for equestrians and cowboy action shooters to participate in a competitive shooting sport while riding horseback.[2][3] The Mounted Shooters of America was formed in 2000 and may belong to either or both associations.

Mounted shooting requires competitors to use four guns (2 single-action revolvers, 1 lever-action rifle chambered in pistol caliber, and 1 side-by-side double-barreled shotgun). Single action semi-automatic firearms, also known as self-cocking firearms, are also allowed in special military cavalryand Wild Bunch events (named after the 1969 Western movie of the same



name that used more modern firearms). In general, firearm designs and the modern replicas used in the sport are of the pre-1900 American West and Military eras.[4]

All events, whether for Old West living history or shooting competitions, are directed by a certified mounted range officer who must be knowledgeable of firearm safety, event organization, and horsemanship. The direction of a mounted range officer helps to ensure the safety of the competitor, spectators and volunteers at all events



Did you know about the linden tree?

The sweet smelling linden tree with its heart-shaped leaves is associated with Freya, the Germanic Goddess of truth and love. It was believed that you could not tell a lie under the linden tree. Large linden trees were places of social gathering and weddings, as well as places to assemble to create laws and render judicial verdicts. In a Greek myth, the gods Zeus and Hermes disguise themselves as peasants and go door-to-door seeking food and shelter, but are turned away by all save an elderly couple, Baucis and Philemon. As a reward for the couple's hospitality, the gods transformed them upon their deaths into an intertwining oak and linden tree.

The wood of the linden tree has fine acoustic properties and is used in many instruments, from the electric guitar to recorders and percussion instruments. I think of the linden as a musical tree, not only for the uses of its wood, but also because when it blooms in the summer it's abuzz with the music of bees. The linden is an excellent tree for supporting bee populations, and linden honey is considered exceptionally flavorful.

With more than 6 million striped bass harvested each year averaging 10 to 20 pounds each — recovering just 5 percent more meat from every fish could save millions of pounds of meat annually from this one species alone and preserve the tradition for many years to come.

Striper Regulations and Conservation

Striped bass (Morone saxatilis), or stripers or rock bass depending on where you fish, are one of the most prized catches along the Atlantic Coast of North America, especially among Northeastern sport anglers who value them for their powerful fight and delicious, flaky meat.

These anadromous fish migrate between salt water and fresh throughout their lives, historically thriving from the St. Lawrence River southward. However, their populations have declined due to overfishing, habitat loss, enseveral years of poor reproduction.

In response, regulatory bodies have implemented size limits, slot limits and seasonal restrictions to protect spawning adults and juvenile fish. Recent striped bass conservalimits for recreational anglers mercial fishermen, have shown promising results in helping stabilize the popula-

Commercial fishermen face rigid quotas and gear restrictions designed to minimize bycatch and prevent overharvesting. Meanwhile, recreational anglers are encouraged to practice careful catchand-release and follow new regulations aimed at protecting larger breeding fish. As stewards of the waters, it's vital that anglers and commercial harvesters alike balance their passion for fishing with sustainable practices to

> Striper collars offer two distinct types of meat: the rich, fatty collar meat and the tender pectoral fin meat. Both are incredible and are great roasted, grilled or fried. One of my favorite ways to prepare them is with a bold, savory marinade.

I mix soy sauce, honey, sriracha, freshly grated ginger and garlic into a smooth sauce. Let the collars soak in this mixture for a bit, then roast them in a 425°F oven for 15 to 20 minutes. Once they're done, plate the collars over a bed of rice, drizzle the remaining sauce from the baking dish on top, and garnish with thinly sliced chives. After one bite, you'll never toss out striper collars-or any fish collarsagain.

5 Steps to fillet a Striped Bass

Step 1: The First Cut The edible portion of a striper collar includes the fatty collar meat and the tender pectoral meat. Cam Brooks

Start by lifting the pectoral fin and making a clean, angled cut just behind the head. Avoid cutting straight down-you'll risk leaving behind valuable meat near the head. Striper scales are tough, but angling your knife not only secures

fish's back, just above the dorsal fin. Keep your knife angled for a pushing motion rather than a sawing one. This technique preserves the integrity of the fillet (check out the video below for a visual guide).

Step 3: Every Ounce of Striper

Use the skeleton to help guide your knife as you pull back the fillet. Cam Brooks

Once you reach the spine, rest your knife gently on the backbone and pull toward the head, allowing the skeleton to guide your blade. This method ensures you capture every ounce of that prized striper meat. After a few long, controlled strokes, you should reach the center of the spine. Step 4: Cut Out a Rib-Free Striped bass Fillet

Lift the striper's high loin carefully to get a better angle for your knife to glide over the ribs. Cam Brooks

Now, place just the knife tip at the base of the ribs, angle the blade slightly upward, and push forward to separate the pin bones from the rib cage. This step will free the top of the high loin. Lift it carefully to create a better angle for gliding the knife over the ribs, allowing you to remove a clean, rib-free fillet.

cover a large bear was spending its days lounging by his pool, and its nights sleeping under his house.

Sean Lorenzini said the bear made itself at home in the crawlspace under his Pasadena home, and can frequently be seen venturing out of its den to lounge by the pool and steal trash from his neigh-

"I think it found refuge under the house during the fire, and it's definitely not moving — that's its home," Lorenzini told the Los Angeles Times.

Lorenzini's discovery came after Altadena resident Samy Arbid returned to his own home last month to discover a large bear in his crawlspace. The California Department of Fish and Wildlife set a humane trap for the bear and safely relocated it to a wilderness area far from the house.

Lorenzini said he is hoping officials will do the same for his unwanted downstairs neighbor, which he nicknamed

Neighbors said they believe Yogi is a bear that has been spotted wandering the area for several years, but hadn't made trouble until moving into the crawlspace.

"We are having some fuses blown, so he's down there obviously whacking things around," Lorenzini told KTLA-TV said. "Some of the insulation has been pulled out."

CDFW officials said they are aware of the bear living under the house and are working to determine the best approach for evicting the ursine squat-

"I need him out," Lorenzini said. "I don't want him hurt but I need him removed and I think he's just going to come back."

Feb. 18 (UPI) — Authorities in California rounded up 11 donkeys found running loose in a



San Diego County industrial park.

The San Diego County Sheriff's Office said the donkeys were reported near Business Park Drive and Sycamore Avenue in Vista on Monday. Deputies called for assistance from the San Diego Humane Society.

The couple raised 13 children, and now have 55 grandchildren, 54 great-grandchildren and 12 great-greatgrandchildren.

The longest marriage ever lasted for 88 years and 349 days. David Jacob Hiller and Sarah Davy Hiller were married in 1809 in Canada.

Feb. 14 (UPI) — A 24-year-old kayaker in Chile was briefly swallowed, and subsequently regurgitated, by a humpback whale in an unusual encounter his father caught on cam-
