<u>Watch Commander's ...</u> **Day & night report**

On January 29, the San Joaquin County Human Trafficking Task Force (ASALT), Stanislaus County HEAT (Human Exploitation and Trafficking) Task Force, and local agencies successfully carried out an operation focused on combating human trafficking and protecting vulnerable victims. The operation included five traffic stops, resulting in a total of three arrests.

Among the arrests were individuals facing a range of charges, including felony kidnapping, felony evading, felony robbery, and misdemeanor disorderly conduct related to prostitution.

Notably, two victims were recovered during the operationone adult and one juvenile.

A key moment of the operation involved the recovery of a 17year-old juvenile victim, who had been missing from her placement in Southern California. The victim, who had been exploited as part of Commercial Sexual Exploitation of Children (CSEC), was spotted jumping from a moving vehicle at a truck stop near Charter Way and Navy Drive in Stockton around 9:50 PM. Law enforcement quickly responded, with the help of an air unit that tracked the suspect vehicle. The pursuit lasted approximately nine miles, culminating in the arrest of Carl Price (DOB: 07/02/91), who now faces multiple charges, including felony kidnapping and felony evading.

Both victims were interviewed during the operation, and victim services were offered. The juvenile victim accepted the services, ensuring her safety and providing support for her recovery. This operation would not have been possible without the collaboration of several dedicated agencies. We extend our deepest gratitude to law enforcement partners, the San Joaquin County Probation, Stockton Police Department, Stanislaus County Sheriff's Office, Homeland Security Investigations, Manteca Police Department, and the San Joaquin County District Attorney's Office. As well as our victim service partners, San Joaquin County Family Justice Center, Without Permission, PREVAIL, and the San Joaquin County Human Services Agency.

Together, local law enforcement remains committed to the fight against human trafficking and will continue to work tirelessly to ensure justice and recovery for all victims.



"People do not learn from mistakes," said the professor. The class was confused. Most of



them had been taught all of their lives that the best way to learn was from one's mistakes. As he looked into their puzzled faces, he continued his lecture by asking a question, "How many of you have made the same mistake twice?" Hands went up all over the classroom. "That is precisely my point. If we learned from our mistakes, we would never make the same mistake twice. We seem to learn best when someone provides us feedback. We are not honest enough with ourselves to point out our own mistakes or failures. We do not want to admit them - especially to ourselves even if we recognize them."

The author of this Psalm recalled two important facts: When the Israelites acknowledged God as their leader and followed Him, they were victorious. "Our fathers advised us," they said, "that it was not our swords or plans that brought victory." God spoke to them and they realized what brought about their defeat: they trusted in their own strength! It was their defeat that caused them to be open to God's "feedback."

When "we pushed back our enemies in Your name," he continued, "we trampled on our foes!" What a testimony to the power and victory that is available to us through our God!

Like Israel, we must come to the same conclusion and make the same confession with the same amount of conviction: "in Your name, Heavenly Father, we can trample on our foes." If we have fallen into sin and need forgiveness, if we have failed to witness to those around us who have not experienced God's saving grace through Christ, if we have failed to do what God exnects us to do - with Him we can trample our foes!"



WWII Army hero returns home

WASHINGTON— The Defense POW/MIA Accounting Agency announced that U.S. Army Air Forces Sgt. James H. Murray, 25, (pictured, right) of Hollywood, Calif, who was captured and died as a prisoner of war during World War II, was accounted for Sept. 23, 2024.

Murray's family recently received their full briefing on his identification, therefore, additional details on his identification can be shared.

In late 1941, Murray was a member of the 93rd Bombardment Squadron, 19th Bombardment Group, when Japanese forces invaded the Philippine Islands in December. Intense fighting continued until the surrender of the Bataan peninsula on April 9, 1942, and of Corregidor Island on May 6, 1942. Thousands of U.S. and Fili-

pino service members were captured and interned at POW camps. Murray was among those reported captured when U.S. forces in Bataan surrendered to the Japanese. They were subjected to the 65-mile Bataan Death March and then held at the Cabanatuan POW Camp #1. More than 2,500 POWs perished in this camp during the war.

According to prison camp and other historical records, Murray died Nov. 22, 1942, and was buried along with other deceased prisoners in the local Cabanatuan Camp Cemetery in Common Grave 816.

Following the war, American Graves Registration Service

personnel exhumed those analysis. buried at the Cabanatuan Althou



cemetery and relocated the remains to a temporary U.S. military mausoleum near Manila. In 1947, the remains were examined in an attempt to identify them. One of the sets of remains from Common Grave 816 were identified, while the remaining three were declared unidentifiable. The unidentified remains were buried at the Manila American Cemetery and Memorial as "Unknowns".

In 2019, as part of the Cabanatuan Project, DPAA exhumed the remains associated with Common Grave 816 and sent them to the laboratory for analysis.

To identify Murray's remains, scientists used dental and anthropological analysis, as well as circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA and mito-

Although interred as an Unknown, Murray's grave was meticulously cared for over the past 70 years by the American Battle Monuments Commission. Today, Murray is memorialized on the Walls of the Missing at the Manila American Cemetery and Memorial in the Philippines. A rosette will be placed next to his name to indicate he has been accounted for.

Murray will be buried in Arlington National Cemetery, on a date yet to be determined.

The total distance marched to various camps was 65 miles. Sources also report widely differing prisoner of war casualties prior to reaching Camp O'Donnell: from 5,000 to 18,000 Filipino deaths and 500 to 650 American deaths during the march. The march was characterized by severe physical abuse and wanton killings. POWs who fell or were caught on the ground were shot. After the war, the Japanese commander, General Masaharu Homma and two of his officers, Major General Yoshitaka Kawane and Colonel Kurataro Hirano, were tried by United States military commissions for war crimes and sentenced to death on charges of failing to prevent their subordinates from committing atrocities. Homma was executed in 1946, and Kawane and Hirano in 1949.

The Japanese government never formally apologized until 2010, They agreed to let American POWs make a visit to Japan and receive an apology. On Sept 13, 2010, Minister of Foreign Affairs Katsuya Okada apologized to six American POWs, including two survivors of the Bataan Death March, Lester Tenney and Robert Rosendahl.

Most of the men were sick, they had dysentery, they had malaria, they had a gunshot wound." Their Japanese captors showed no mercy for the ill or wounded, Tenney said. "A man would fall down and they would holler at him to get up," he added. "I saw a case where they didn't even holler at him. The man fell down, the Japanese took a bayonet and put it in him. I mean, two seconds."

Farallons abandoned

For the first time since the 1800s, the Farallon Islands off the coast of San Francisco, will no longer have a year-round human presence.

Due to federal budget cuts that predate the current administration, as well as \$10 million in needed repairs, biologists from Point Blue Conservation Science will now leave in September, returning only seasonally from mid-March to mid-September, according to the San Francisco Chronicle.

This change threatens decades of conservation efforts that helped species like common murres and northern fur seals recover.

Without researchers on site, key data on elephant seals, white sharks, and whale migrations will be lost, and the islands will be more vulnerable to human disturbances.

The reduced presence also means fewer resources to combat invasive species like house mice, which disrupt the fragile ecosystem.

Officials estimate that scaling back will lower annual maintenance costs from \$600,000 to about \$106,400, but essential infrastructure, including the island's crane and water systems, remains in disrepair.

Point Blue is urgently seeking funding to maintain a yearround presence in some capacity, hoping for a last-minute solution to avoid abandoning the islands entirely.



There are two major problems, water experts said: The newly released water will not flow to Los Angeles, and it is being wasted by being released during the wet winter season.

"They were holding extra water in those reservoirs because of the risk that it would be a dry summer," said Heather Cooley, director of research for California water policy organization the Pacific Institute. "This puts agriculture at risk of insufficient water during the summer months."

Trump posted that 1.6 billion gallons was being released adding that "in 3 days, it will be 5.2 billion gallons."

About 2.2 billion gallons were released, local water districts said in a statement. That water was discharged into the dry lakebed of Tulare Lake, according to a letter from Sen. Alex Padilla to Secretary of Defense Pete Hegseth.

"Downstream entities used these releases for limited irrigation demand and groundwater recharge," the statement said. "This release is extremely concerning," Cooley said. "It's providing zero benefit and putting California farmers at risk of water supply constraints in the coming months."

California Department of Water Resources director Karla Nemeth told reporters that there was little coordination between federal officials and the state and local water managers for the Army Corps releases at the Terminus Dam at Lake Kaweah and Schafer Dam at Lake Success.

"These reservoirs were federal reservoirs, and the state of California was not part of the decision making in this instance," Nemeth said. "We traditionally have a high degree of coordination at the operational level, which really wasn't a part of this decision."

California's State Water project supplies water from Northern California to Southern California, including to Los Angeles. Los Angeles' water supply comes partly from state reservoirs and partly from the Colorado River.

But Los Angeles' water sources are completely separated from the water system that Lake Kaweah and Lake Success supply. That water system flows into the agriculture-heavy Central Valley — where large farms grow nuts, citrus and grasses for animal feed, among other crops. The water-stressed region is heavily reliant on groundwater and winter precipitation stored in state reservoirs to irrigate crops.

The US Army Corps of Engineers and the White House did not respond to CNN's request for comment.




